The Town of Oakville has received a complete application by Acclaim Health and Community Care Services to extend Temporary Use By-law "T2".

The Planning Services department will be presenting a recommendation report with respect to this development proposal at this meeting.

The purpose of this application is to extend Temporary Use By-law T2 which would permit continued use of the subject property for respite care in association with a day care for an additional 3 years.

The subject property is located on the south side of Speers Road between Bronte Road and Third Line.

At this time there are no other applications, under the *Planning Act*, R.S.O. 1990, c. P.13, as amended, pertaining to the subject lands.

If a person or public body does not make oral submissions at a public meeting, or make written submissions to Council c/o the Town Clerk at the Town of Oakville, Clerk's department, before the bylaw is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.
