The Town of Oakville has received a complete application by Argo Lions Valley Ltd. for a proposed zoning by-law amendment and proposed plan of subdivision.

The applicant has applied for a Zoning By-law Amendment and Plan of Subdivision. The purpose of the application is to subdivide the land and rezone the majority of the site from Future Development (FD) to General Urban (GU), Natural Heritage System (NHS) and Stormwater Management Facility (SMF) under Zoning By-law 2009-189 (the "Zoning By-law") along with site specific amendments for the subject property to allow for a combination of townhouse blocks and detached lots resulting in 131 dwellings.

The subject lands are located on the north side of Dundas Street West between Pavilion Path and Lions Valley Park and are municipally known as 1303 Dundas Street West.

At this time there are no other applications, under the *Planning Act*, R.S.O. 1990, c. P.13, as amended, pertaining to the subject lands.

If a person or public body would otherwise have an ability to appeal the decision of the Town of Oakville to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to Council c/o the Town Clerk at the Town of Oakville, Clerk's department, 1225 Trafalgar Road, Oakville, ON L6H 0H3 (Dropbox is located in front of Town Hall) or at <a href="TownClerk@oakville.ca">TownClerk@oakville.ca</a> before the zoning by-law is passed, and before the approval authority gives or refuses to give approval to the draft plan of subdivision, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submissions at a public meeting, or make written submissions to Council c/o the Town Clerk at the Town of Oakville, Clerk's department, before the zoning by-law is passed, and before the approval authority gives or refuses to give approval to the draft plan of subdivision, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so and is not entitled to appeal the decision of the Director of Planning and Development to the Ontario Land Tribunal.
