THE CORPORATION OF THE TOWN OF OAKVILLE BY-LAW NUMBER 2025-085

A By-law to clarify the repeal of By-law 2021-077and related amending by-laws through By-law 2023-021

WHEREAS By-law 2023-021, also referred to as the Municipal Powers and Delegation By-law, is "A by-law to delegate certain powers and duties under the Municipal Act, S.O. 2001 c.25, the Planning Act, R.S.O. 1990 c. P. 13, and other Acts, and to repeal By-law 2021-077, as amended, and to repeal By-law 2012-013."

WHEREAS the recitals to By-law 2023-021 include the following:

AND WHEREAS Council wishes to consolidate previous delegations of authority to officers, employees or committees, through various by-laws and to further delegate powers and duties as set out under this By-law;

AND WHEREAS delegations under certain other by-laws, are not intended to be addressed in this By-law but shall remain in full force and effect;

WHEREAS Section 20 of By-law 2023-021 repealed By-law 2021-077 along with amending by-laws as follows:

By-law 2021-077 is hereby repealed, along with amending by-laws 2022-022, 2022-036, 2022-040, 2022-045, 2022-093.

WHEREAS By-law 2022-093, also referred to as the Site Plan By-law, is "A by-law to establish site plan control, delegate authority with respect to the approval of site plans within the Town of Oakville, repeal By-law 2019-114 and amend By-law 2021-077."

WHEREAS section 20 is the only section of By-law 2022-093 that contains an amendment to By-law 2021-077;

WHEREAS the balance of By-law 2022-093 deals with matters related to the exercise of the town's authority under Section 41 of the *Planning Act*, including matters which are unrelated to the delegation of authority;

WHEREAS paragraph 48 of Appendix "A" to By-law 2023-093 specifically refers to and relies on By-law 2022-093 in relation to the delegation of authority under section 41 of the *Planning Act*, in a manner that would be inconsistent with a possible repeal of the entirety of By-law 2022-093:

WHEREAS Council wishes to clarify that the reference to the repeal of By-law 2022-093 described in section 20 of By-law 2023-021 only applied to the portion of By-law 2022-093 that qualified as an "amending by-law" to By-law 2021-077.

COUNCIL ENACTS AS FOLLOWS:

- 1. Section 20 of By-law 2023-021 is hereby amended by adding the words "and section 20 of By-law" prior to "2022-093" as follows:
 - By-law 2021-077 is hereby repealed, along with amending by-laws 2022-022, 2022-036, 2022-040, 2022-045, **and section 20 of By-law** 2022-093.
- 2. The balance of By-law 2022-093, other than section 20, is deemed to have never been repealed by By-law 2023-021 and has remained in full force and effect since its date of passing.

THE CORPORATION OF THE TOWN OF OAKVILLE BY-LAW NUMBER 2025-084

A by-law to confirm the proceedings of a meeting of Council.

COUNCIL ENACTS AS FOLLOWS:

- 1. Subject to Section 3 of this by-law, every decision of Council taken at the meeting at which this by-law is passed and every resolution passed at that meeting shall have the same force and effect as if each and every one of them had been the subject matter of a separate by-law duly enacted.
- 2. The execution and delivery of all such documents as are required to give effect to the decisions taken at the meeting at which this by-law is passed and the resolutions passed at that meeting are hereby authorized.
- 3. Nothing in this by-law has the effect of giving to any decision or resolution the status of a by-law where any legal prerequisite to the enactment of a specific by-law has not been satisfied.
