Under Section 45(1) of the *Planning Act*, the applicant is requesting the Committee of Adjustment to authorize a minor variance to permit the construction of a two-storey detached dwelling and cabana on the subject property proposing the following variance(s):

1	<b>Section 5.8.6 c)</b> For <i>lots</i> located within the Residential Low (RL1) <i>Zone</i> the maximum total <i>floor area</i> for a <i>private garage</i> shall be 56.0 square metres.	To permit the maximum <i>total floor area</i> for the <i>private garage</i> to be 62.0 square metres.
2	<b>Table 6.3.1 (Row 5, Column RL1)</b> The <i>minimum interior side yard</i> shall be 4.20 m.	To permit a <i>minimum</i> (southerly) <i>interior side yard</i> of 3.0 m.
3	<b>Section 6.4.1</b> The maximum <i>residential floor area ratio</i> for a <i>detached dwelling</i> on a <i>lot</i> with a <i>lot area</i> 1301.00 m <sup>2</sup> or greater shall be 29% (441.29 m <sup>2</sup> ); (Lot area is 1,521.69 m <sup>2</sup> ).	To permit the maximum <i>residential floor area ratio</i> for the <i>detached dwelling</i> to be 30.58% (465.33 m <sup>2</sup> ).

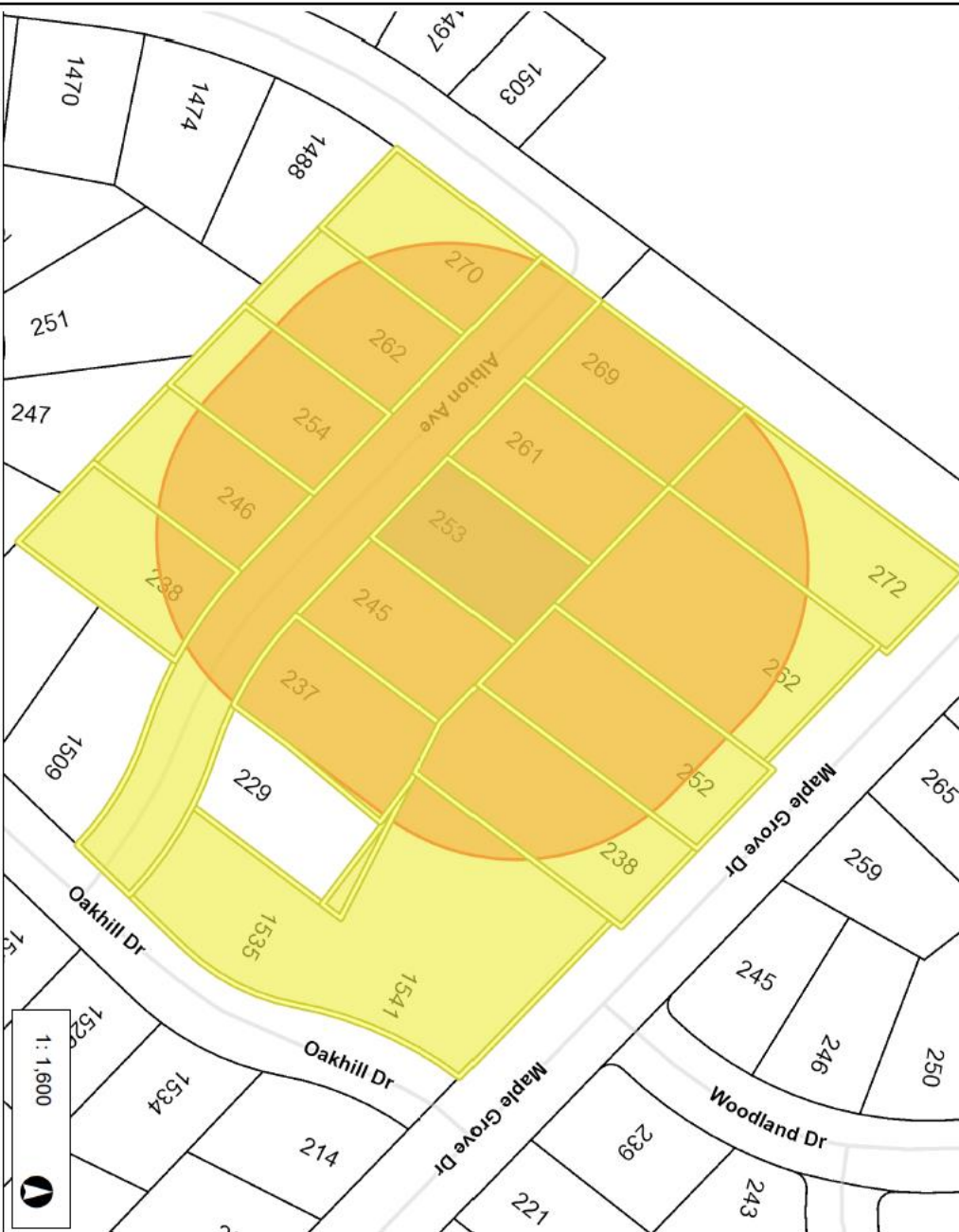
