



THE CORPORATION OF THE TOWN OF OAKVILLE BY-LAW NUMBER 2022- 036

A by-law to amend By-law 2010-163 being a by-law to delegate certain powers to the Oakville Appeals Committee and to amend By-law 2021-077 being a by-law to delegate certain powers and duties under the Municipal Act, 2001, S.O. 2001 c.25, the Planning Act, R.S.O. 1990 c. P. 13, and other Acts.

WHEREAS By-law 2010-163 delegates certain powers and duties to the Oakville Appeals Committee, and was passed by Council on October 4, 2010;

WHEREAS By-law 2021-077 consolidates delegations of authority to officers, employees or committees, and was passed by Council on September 28, 2021;

WHEREAS Council wishes to amend By-law 2010-163 and By-law 2021-077;

COUNCIL ENACTS AS FOLLOWS:

- 1. Section 1 of By-law 2010-163 is hereby amended as follows:
 - (i) the word "and" be deleted from the end of subsection 1(d);
 - (ii) the subsections dealing with the Private Tree By-law and the Cemetery By-law be re-lettered and amended to read as follows:
 - e. Appeals filed in accordance with the Private Tree By-law relating to the issuance of tree permits;
 - f. Appeals filed in accordance with the Cemetery By-law relating to the rules and regulations for Town of Oakville cemeteries;
 - (iii) new subsections g, h, i and j be added as follows:
 - g. Appeals under Part 15 of the Sign By-law that are to be dealt with by the Appeals Committee;
 - h. Appeals under the Fence By-law that are to be dealt with by the Appeals Committee;

- i Appeals filed in accordance with the Noise By-law relating to the issuance of noise exemption permits;
- j Appeals filed in accordance with the Public Nuisance By-law relating to the issuance of exemption permits; and
- (iv) The subsection dealing with additional appeals and complaints be relettered as follows:
 - k. Additional appeals and complaints as may be determined by Council in future and included in the Oakville Appeals Committee mandate.
- 2. Column 1 of subsection 65 of Schedule A Appeals Committee of By-law 2021-077 is hereby amended as follows:
 - (i) adding new subsections I) and J) as follows:

- appeals filed in accordance with the Public Nuisance By-law relating to the issuance of exemption permits; and

 - K) additional appeals and complaints as may be determined by Council in future and included in the Oakville Appeals Committee mandate
- 3. All other provisions of By-law 2010-163 and By-law 2021-077 hereby remain in force and effect.
