Under Section 45(1) of the *Planning Act*, the applicant is requesting the Committee of Adjustment to authorize a minor variance to permit the construction of ground floor and second floor additions and renovations of the existing dwelling on the subject property proposing the following variances:

3	<b>Section 15.11.1 h)</b> The maximum <i>residential floor area ratio</i> for a <i>dwelling</i> having two or more storeys shall be 30% (279.33 m <sup>2</sup> ). (Lot area is 931.1 m <sup>2</sup> ).	To permit the maximum <i>residential floor area ratio</i> for the <i>dwelling</i> having two <i>storeys</i> to be 37.47% (348.91 m <sup>2</sup> ).

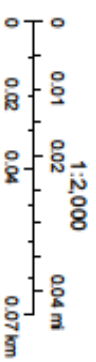
