Under Section 45(1) of the *Planning Act*, the applicant is requesting the Committee of Adjustment to authorize a minor variance to permit the construction of a second story addition to the existing 2 storey detached dwelling on the subject property proposing the following variance:

No.	Zoning By-law Regulation	Variance Request
1	Section 6.4.1 The maximum <i>residential floor area ratio</i> for a <i>detached dwelling</i> on a <i>lot</i> with a <i>lot area</i> between 650.00 m ² and 742.99 m ² shall be 41% (285.77 m ²); (Lot area is 697.00 m ²).	To permit the maximum <i>residential floor area ratio</i> for the <i>detached dwelling</i> to be 44.01% (306.75 m ²).

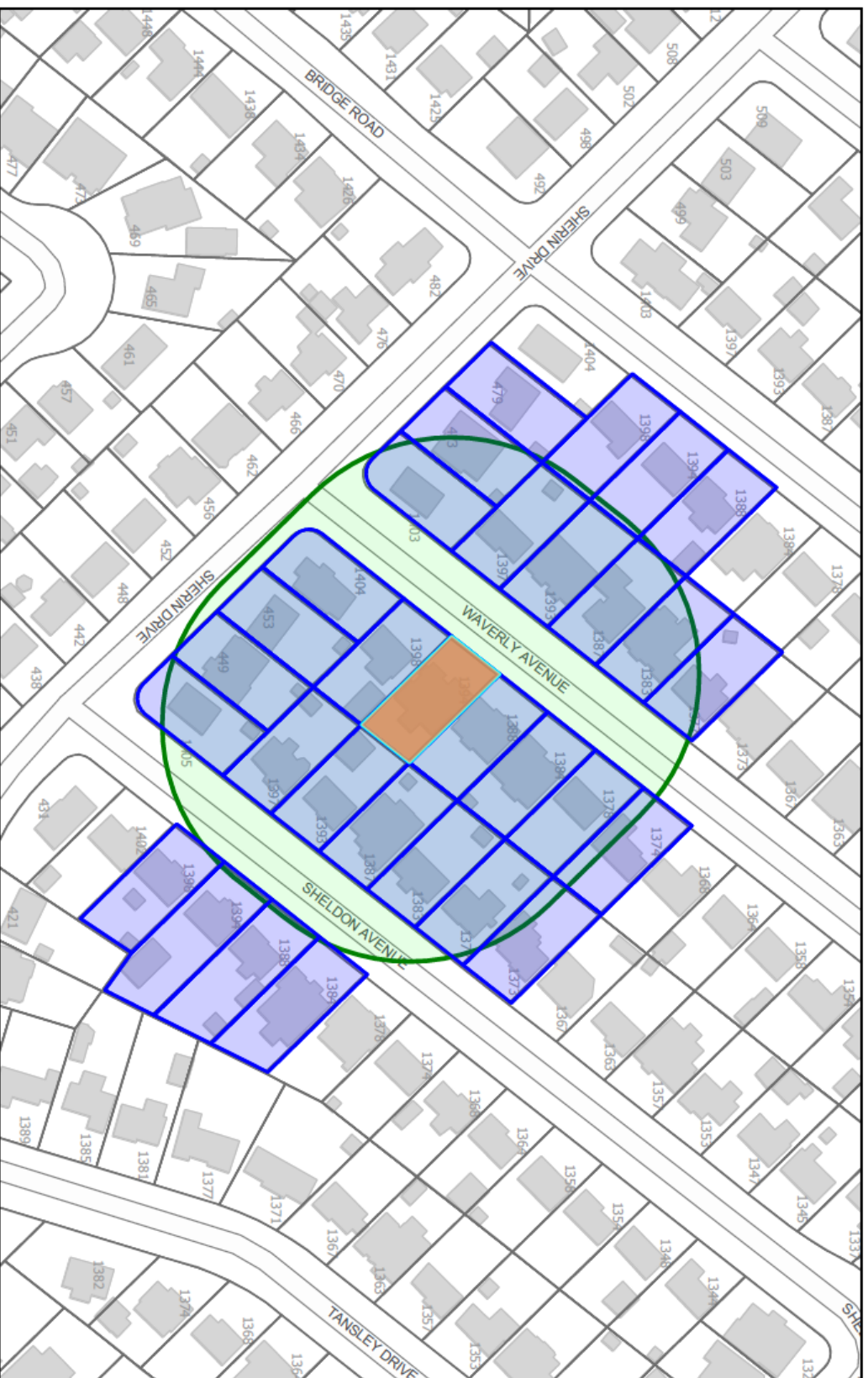
