Under Section 45(1) of the *Planning Act*, the applicant is requesting the Committee of Adjustment to authorize a minor variance to permit the construction of a covered porch and uncovered platform on the subject property proposing the following variance(s):

1	Table 4.3 (Row 16) Uncovered platforms having a floor height equal to or greater than 0.6 metres measured from grade shall be located in a front or rear yard with a maximum total encroachment of 1.5m into a minimum yard.
