Variance Request:

Under Section 45(1) of the *Planning Act*, the applicant is requesting the Committee of Adjustment to authorize a minor variance to permit the construction of a two-storey detached dwelling on the subject property proposing the following variances:

1	Section 5.8.6 b) For <i>detached dwellings</i> on lots having greater than or equal to 12.0 metres in <i>lot frontage</i> , the maximum total <i>floor area</i> for a <i>private garage</i> shall be 45.0 square metres. 3	Table 6.3.2 (Row 9, Column - Detached dwellings) The maximum <i>lot coverage</i> shall be 35% (191.96 m ²); (Lot Area is 548.45 m ²).	To permit the maximum <i>lot coverage</i> to be 36.0% (197.44 m ²).

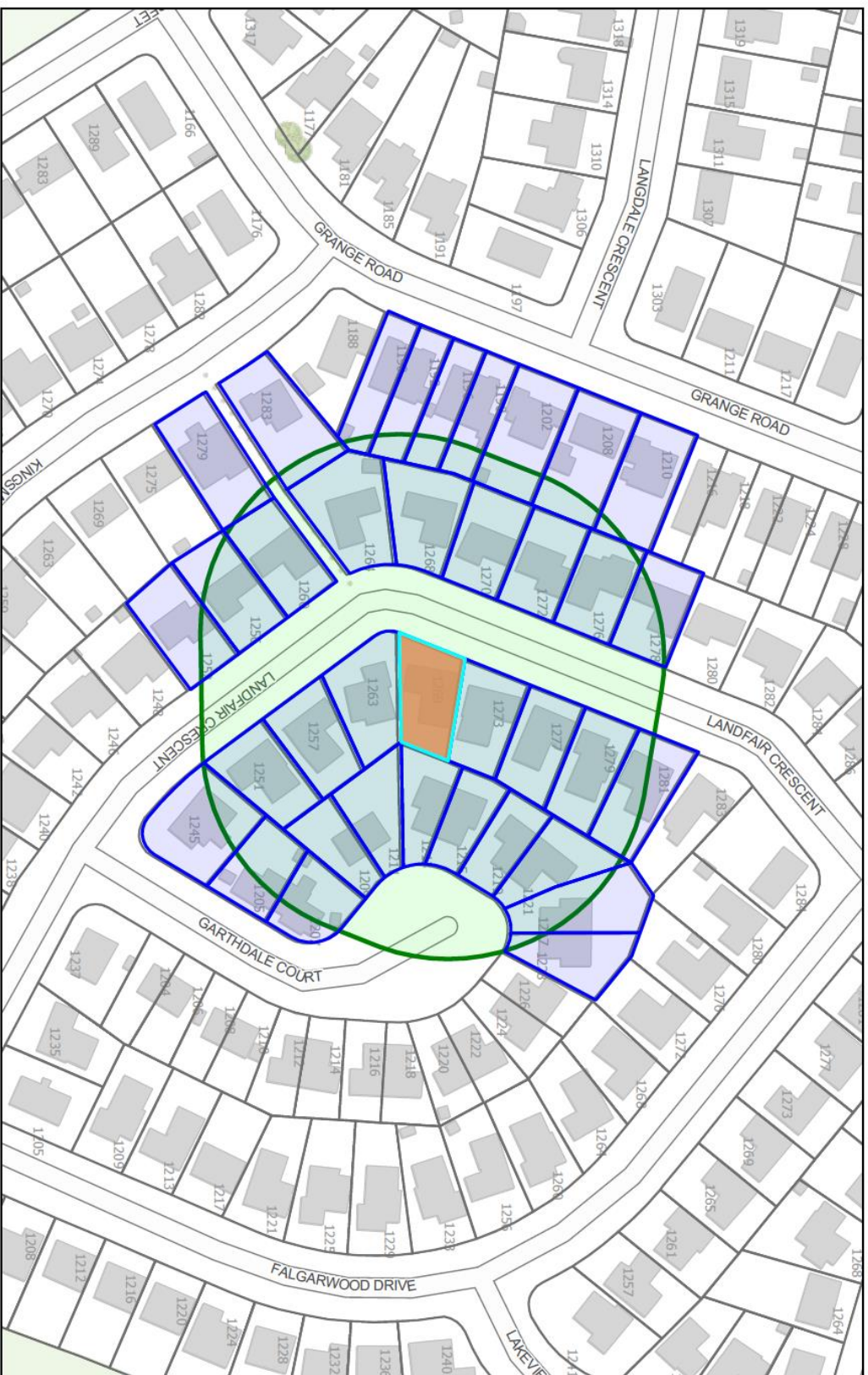
