1	Section 6.4.2 a) (Row RL2, Column 3) The maximum <i>lot coverage</i> shall be 25% (271.52m ²) where the <i>detached dwelling</i> is greater than 7.0 metres in <i>height</i> ; (Lot area is 1086.09m ²).	To permit the maximum <i>lot coverage</i> to be 27.32% (296.73m ²) for the <i>detached dwelling</i> which is greater than 7.0 metres in <i>height</i> .

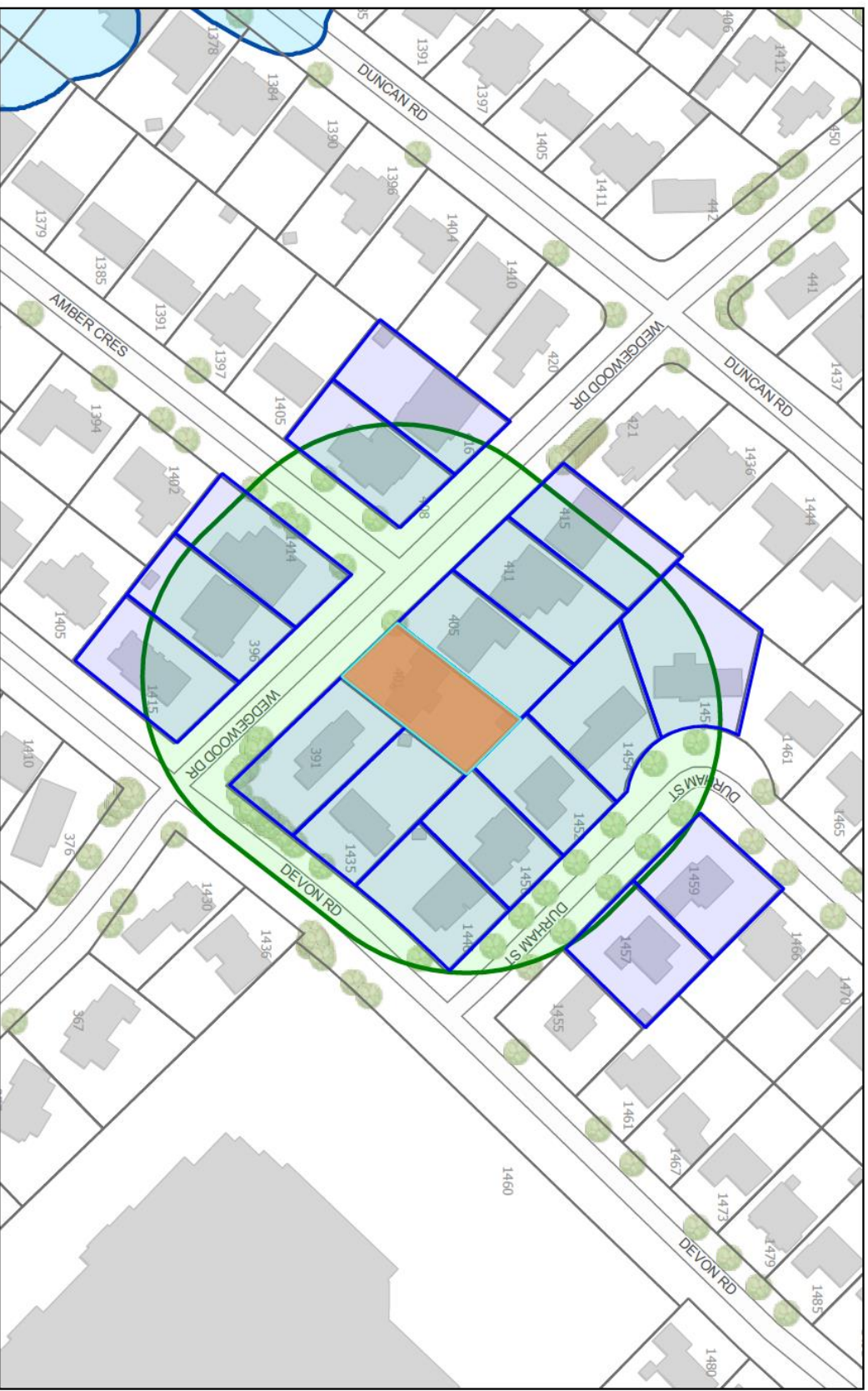

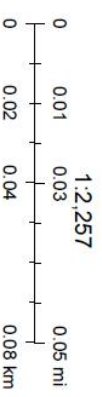
