1	<b>Section 6.4.1</b> The maximum residential floor area ratio for a detached dwelling on a lot with a lot area between 650.00 m² and 742.99 m² shall be 41% (276.29 m²); (Lot area is 673.90 m²).	To permit the maximum residential floor area ratio for the detached dwelling to be 44.2% (297.86 m²).
2	Section 6.4.3 a) The minimum front yard on all lots shall be the yard legally existing on the effective date of this By-law less 1.0 metre; (Existing 12.38 m -1.0 m = 11.38 m minimum).	To permit a <i>minimum front yard</i> of 8.46 metres.
3	<b>Section 6.4.6 c)</b> The maximum <i>height</i> shall be 9.0 metres.	To permit a maximum <i>height</i> of 10.62 metres.
