Under Section 45(1) of the *Planning Act*, the applicant is requesting the Committee of Adjustment to authorize a minor variance to permit the construction of a two-storey detached dwelling on the subject property proposing the following variances:

1	<b>Table 6.3.1 (Row 5, Column RL2)</b> The <i>minimum interior side yard</i> shall be 2.40 m.	To permit a <i>minimum</i> westerly <i>interior side yard</i> of 1.21 m.
2	<b>Section 6.4.3 a)</b> The <i>minimum front yard</i> on all <i>lots</i> shall be the <i>yard</i> legally existing on the effective date of this By-law less 1.0 metre; (Existing 12.32 m -1.0 m = 11.32 m minimum).	To permit a <i>minimum front yard</i> of 7.55 metres.
3	<b>Section 6.4.5</b> <i>Balconies and uncovered platforms</i> are prohibited above the floor level of the <i>first storey</i> on any <i>lot</i> in the -0 Suffix Zone.	To permit two <i>balconies</i> above the floor level of the <i>first storey</i> .
4	<b>Section 6.4.6 c)</b> The maximum <i>height</i> shall be 9.0 metres.	To permit a maximum <i>height</i> of 11.46 metres.

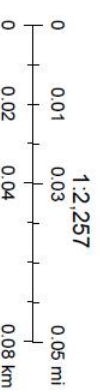
