The following are key points for consideration with respect to this report:

- Sixteen Mile Relocation project has started with the branch closing to the public as of Sunday, June 5.
- The Sixteen Mile Sports Complex Pop-up opened on Tuesday, June 7.
- The Provincial Election was on June 2 and a majority PC government was elected. Both Oakville MPP's retained their seats.
- A North Park Development Update Community Centre, Library and Park report is going to Council on Monday, June 20 and will address the financial pressures currently facing the project.


### **BACKGROUND:**

#### **Sixteen Mile Branch Relocation**

Sixteen Mile Branch successfully closed as of Sunday, June 5 with the Sixteen Mile Sports Complex Pop-up opening in Tuesday, June 7. Response to the pop-up has been positive to date. The expansion of additional lockers and the Browse and Borrow Kiosk should be operational by the end of June.



An update on the move of the branch will come to the board meeting on June 23 as part of the CEO Update report presentation.

### **Provincial Election**

Ontario residents went to the polls on Thursday, June 2 and elected Premier Ford to his second term with a strong majority government. Oakville retained its two existing PC MPP's (Stephen Crawford and Effie Triantafilopoulos). OPL has sent letters of congratulations to both (Appendix A) to both MPP's.

# PC Party of Ontario:

The Ontario government released their <u>2022 Budget on April 28, 2022.</u> No new library commitments are mentioned in this budget, and OLA is working to confirm whether existing provincial funding in support of public libraries is maintained at the previous level. The budget does highlight the previously announced investments in broadband upgrades at libraries:

 "Supporting broadband upgrades at approximately 50 libraries with a provincial investment of \$4.85 million through the Connecting Public Libraries initiative." (p. 45)

### **North Park**

As previously mentioned, the estimated costing for North Park has been updated to reflect current financial pressures and a report (North Park Development Update – Community Centre, Library and Park) is going to Council on June 20. OPL will provide a copy of the report to the Board once it becomes available as well providing an update regarding any decisions and/or items that arise from Council as a result of the report.
