2	Section 6.4.1 The maximum residential floor area ratio for a detached dwelling on a lot with a lot area between 650.00 m² and 742.99 m² shall be 41% (285.17 m²); (Lot area is 695.54 m²).	To permit the maximum residential floor area ratio for the detached dwelling to be 46.17% (321.1 m²).
3	<b>Section 6.4.3 a)</b> The <i>minimum front yard</i> on all <i>lots</i> shall be the <i>yard</i> legally existing on the effective date of this By-law less 1.0 metre; (Existing 9.52 m -1.0 m = 8.52 m minimum).	To permit a <i>minimum front yard</i> of 8.27 metres.


