2	Table 6.3.1 (Row 9, Column RL1) The <i>maximum dwelling depth</i> shall be 20.0 m.	To permit a maximum <i>dwelling depth</i> of 27.73 m.

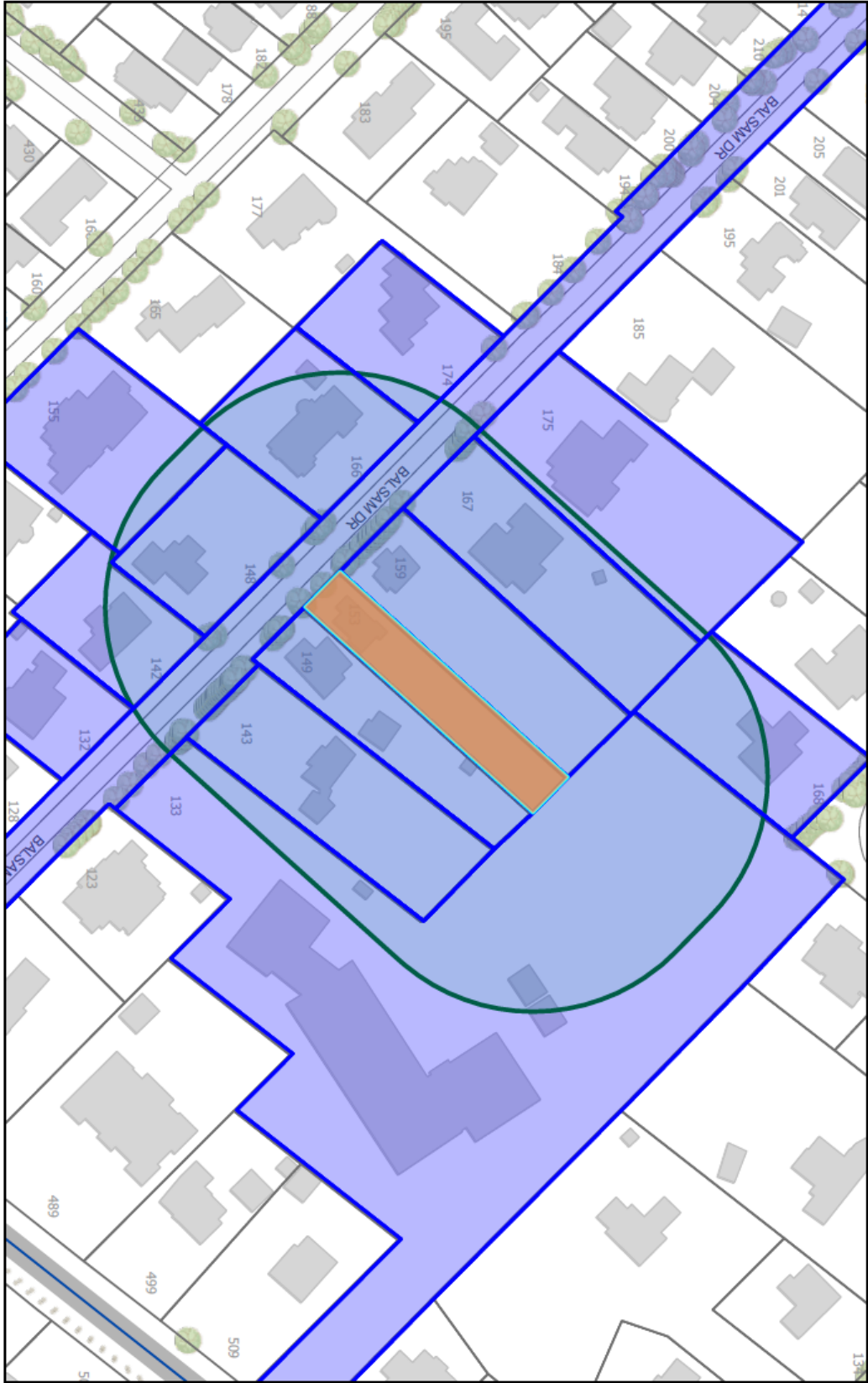
