To permit the maximum <i>lot coverage</i> to be 37.00% (521.40 m ²) for the <i>detached dwelling</i> which is greater than 7.0 metres in <i>height</i> .

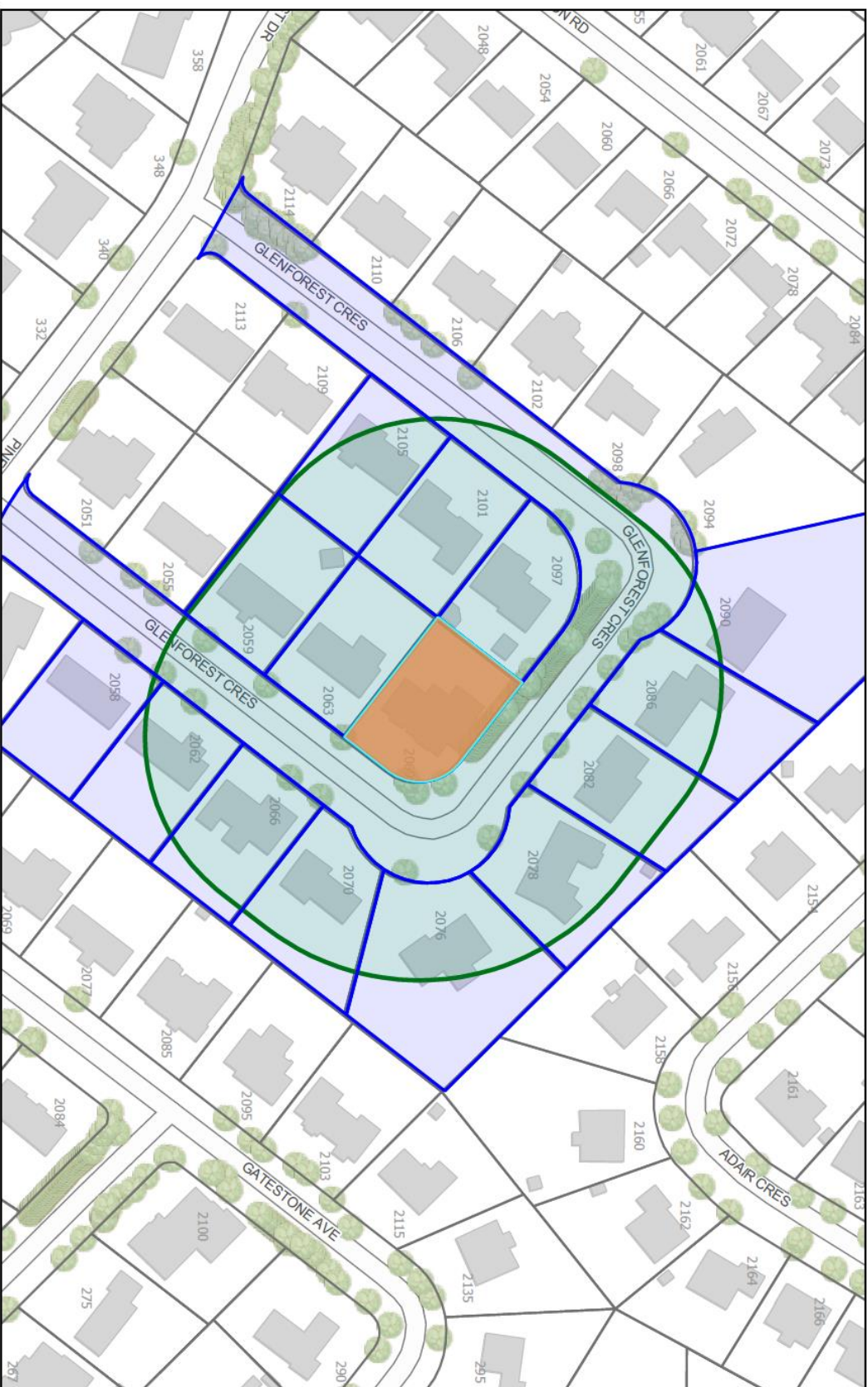
