BY-LAW NUMBER 2023-084

A by-law to amend Parking Administrative Penalties By-law 2015-071 and By-law 1979-59 Regulating Town Parking Lots

WHEREAS By-law 2015-071, as amended, establishes a system of administrative penalties respecting the stopping, standing or parking of vehicles in the Town of Oakville;

WHEREAS it is desirable to amend Table 7 and Table 8 of Schedule A to By-law 2015-071 that set out administrative penalties for contravention of Zoning By-law 2009-189 and Zoning By-law 2014-014 respectively, with respect to parking;

WHEREAS By-law 1979-59 regulates the parking of vehicles on Town parking lots that are controlled by a parking payment machine or a parking permit;

WHEREAS it is desirable to amend Schedules A and B of By-law 1979-59 to include Lot H at Bronte Harbour;

COUNCIL ENACTS AS FOLLOWS:

- 1. Table 7 of Schedule A to By-law 2015-071 titled "BY-LAW 2009-189, AS AMENDED – ZONING (NORTH OF DUNDAS STREET) be amended by adding a new row 1 to read as follows:

Table with 3 columns: Violation, Section, Penalty. Row 1: PARK OTHER THAN ON A DRIVEWAY/SURFACE PARKING, Section 5.1.1.2, \$75.00

- 2. Table 8 of Schedule A to By-law 2015-071 titled "BY-LAW 2014-014, AS AMENDED – ZONING" be amended as follows:

- a. The title of Table 8 be deleted and the following substituted therefor;

"BY-LAW 2014-014, AS AMENDED – ZONING (SOUTH OF DUNDAS STREET)"

- b. New row 7 be added to read:

Table with 3 columns: Violation, Section, Penalty

d. New row 9 be added to read:

PARK TRAILER/RECREATIONAL VEHICLE THAT EXCEEDS THE HEIGHT AND MAXIMUM LENGTH BETWEEN NOVEMBER 1 TO APRIL 30 ON PRIVATE PROPERTY	Section 5.9.2(c)	\$75.00

3. Schedule A - SCHEDULE OF FEES – PARKING LOTS TO WHICH THIS BY-LAW APPLIES to By-law 1979-59 be amended by adding the following new row to the end of the Schedule:
