- 2. That By-law 2023-079, being a by-law to appoint Suzanne Craig as the Corporation of the Town of Oakville Integrity Commissioner pursuant to Section 223.3 of the *Municipal Act, 2001,* as amended, and to repeal By-law 2018-095, be passed.

# 7.8 Eighth Line at Iroquois Shore Road Expropriation, By-law 2023-082 – June 19, 2023

Moved by Councillor Lishchyna

- 1. That the expropriation of the easements and lands set out in Appendix "A" (the "Required Interests"), be approved for the municipal purposes of road widening, reconstruction and improvements to a segment of North Service Road East and Eighth Line and all ancillary works thereto.
- That the CAO and Town Clerk be authorized and directed to sign expropriation plans and Certificates of Approval showing the Required Interests being expropriated.

- 3. That the Town Solicitor be authorized and directed to cause the said expropriation plans, when so signed and sealed, to be registered at the Land Registry Office for Halton and thereby effect the expropriation of the Required Interests.
- 4. That the Realty Services Manager, CAO, Town Solicitor, or any one of them, be authorized and directed to execute and serve all notices and other documents and take such steps which are necessary to carry out the expropriation of the Required Interests or which are required by the *Expropriations Act* in respect of the Required Interests.
- 5. That a Notice of Possession be served requiring possession of the Required Interests at least three (3) months after the date of service of the said notice, and all necessary steps be taken to obtain possession of the Required Interests on the day permitted under the *Expropriations Act*.
- 6. That an offer of an amount in full compensation for the registered owners' interest in the Required Interests, and an offer for immediate payment of 100% of the market value, as estimated by the Town's appraiser, be served, together with a copy of the appraisal report, all in accordance with section 25 of the Expropriations Act.
- 7. Where the registered owner refuses to accept the section 25 offer, that the CAO be delegated authority to approve the compensation for any partial or full minutes of settlement based on market value for the Required Interests, together with any other compensation for which the owners may be entitled to under the *Expropriations Act* in accordance with the procedures and within the monetary threshold limits set out in Appendix "D".
- 8. That any minutes of settlement approved by the CAO be executed in accordance with by-law 2013-057.
- 9. That staff be authorized to undertake any relocation/removal works of structures located within the expropriated Required Interests necessary to commence the construction work if the expropriated owner and the Town cannot reach a settlement, and the Director of Transportation and Engineering be authorized to enter into any agreements required to effect such work.

10. That By-law 2023-082, authorizing the expropriation of the Required Interests, be passed.

- source to a selected supplier rather than engage in a competitive process for procurement so as not to delay the review;
- 2. That staff be directed to install additional community mobile signs on town property for the exclusive use of the BIAs and charitable or non-profit organizations, which allows the recognition of sponsorship in accordance with the Town's Sign By-law, at an estimated cost of \$6,000 to be funded through the Tax Stabilization Reserve, and
- That staff prepare a Policy for Council regarding the use of Town digital kiosks by the BIAs to allow them to include sponsorship details.

# 15.1 Notice of Motion - Declaration of Intimate Partner Domestic Abuse Crisis in Oakville

#### **WAIVING OF PROCEDURE**

Moved by Councillor Elgar Seconded by Councillor Grant

That in accordance with Section 2(2) of the Procedure By-law, Section 14.1(2) of the Procedure By-law be waived to permit consideration of the Notice of Motion regarding Item 15.1 - Notice of Motion - Declaration of Intimate Partner Domestic Abuse Crisis in Oakville, upon its introduction this evening.

WHEREAS the jury that adjudicated the Carol Culleton, Anastasia Kuzyk and Nathalie Warmerdam Inquest (The Renfrew Inquest) issued 86 recommendations to the Province of Ontario on Intimate Partner Violence;

WHEREAS recommendation #1 of the Inquest is for the Province of Ontario to declare Intimate Partner Violence an epidemic;

WHEREAS every six days in Canada a woman is killed by her intimate partner;

WHEREAS on any given night in Canada, over 6,000 women and children sleep in shelters because it is not safe for them at home;

WHEREAS this past year in Ontario, 52 women or one every week, were victims of femicide;

WHEREAS in Halton in 2022 there were 3,503 Intimate Partner Violence calls made to Halton Regional Police and there were 2,342 calls to the Women's Shelter Crisis/Helpline calls;

WHEREAS Halton Women's Place receives 2,500 calls annually to its crisis information and support line, supports 400-600 women through their various outreach services and sees 140 women and children through their safe shelter every year;

Whereas Sexual Assault and Violence Intervention Services of Halton (SAVIS) received over 900 calls on its crisis information and support line, provided counselling services for 872 survivors and services for 64 human trafficking survivors in its most recent fiscal year;

WHEREAS 93% of the CAS domestic violence-related intake cases involve a girl/woman as the primary participant;

WHEREAS the waitlist for counselling can be difficult to access;

WHEREAS violence against women costs the national justice system, health care systems, social service agencies, and municipalities billions of dollars per year; and municipalities are on the front lines in addressing gender-based violence; and

WHEREAS the Town of Oakville Council recognizes that issues of violence against women in all communities are of local importance to the health and wellness of our residents;

NOW THEREFORE BE IT RESOLVED: THAT the Town of Oakville Council:

- recognizes the issues of violence against women and girls in Halton as serious to the health and wellness of local families; and
- is committed to engaging with community partners to educate and support our residents about the seriousness and long-term danger of violence in our community; and

THAT the Town of Oakville Council declares, in accordance with Recommendation #1 of the Renfrew Inquest, that Intimate Partner Violence and Violence Against Women are epidemic; and

BE IT FURTHER RESOLVED THAT this resolution be circulated to The Honourable Doug Ford, Premier of Ontario, The Honourable Charmaine A. Williams, Associate Minister of Women's Social and Economic Opportunity, The Honourable Parm Gill, Minister of Red Tape Reduction, Halton MPP's, Halton Regional Police Service, Halton Regional Police Board, the Association of Municipalities of Ontario, the Federation of Canadian Municipalities, and the Ontario's Big City Mayors.
