#### RECOMMENDATION:

1. That the assumption of Registered Plan 20M-1170 be approved; and

2. That By-law 2023-152, a by-law to assume the completed public works within Registered Plan 20M-1170 be passed.

### **KEY FACTS:**

The following are key points for consideration with respect to this report:

 All public works being recommended for acceptance through this assumption have been inspected and deemed acceptable for assumption.

#### BACKGROUND:

As a requirement of the Subdivision Agreement, when all the obligations of the Owner have been fulfilled, a request may be made to the Town for assumption of the works and streets within the Registered Plan of Subdivision (20M-1170).

The Registered Plan (Appendix B: 20M-1170) identified the location of the plan and area to be assumed by the Town, which consists of ten (10) units, and one (1) walkway block. Appendix B identified the limits of the plan to be assumed.

As set out in the Subdivision Agreement, when the obligations of the Owner have been fulfilled, the Developer may request the Town to assume the public elements within the Plan of Subdivision. The Developer has requested assumption, which has prompted this report to Council.
