1	Table 4.3 (Row 7) The maximum encroachment into a minimum yard for window wells with a maximum width of 1.8 metres shall be 0.6m.	To increase the maximum encroachment into the minimum rear yard for the window well to 0.6 m with a maximum width of 4.27 metres.
2	Section 6.4.1  The maximum residential floor area ratio for a detached dwelling on a lot with a lot area between 743.00 m² and 835.99 m² shall be 40%.	To increase the maximum residential floor area ratio to 44.86%.
