

Traffic Calming on Local and Minor Collector Roads

2024 Progress

- Design and public consultation was completed on the following streets and construction is in progress.
 - Bridge Road from Bronte Road to Stanfield Drive
 - Devon Road from Maple Grove Drive to Brookmill Road.
 - Devon Road from Brookmill Road to Ford Drive.
 - Dunn Street from Trafalgar Road to Randall Street
 - Eden Valley Drive Entire Street.
 - Monks Passage from Nottinghill Gate to Monastery Drive.
- Analyzed twenty-six (26) streets, eleven (11) streets met traffic calming speed and volume thresholds.



Traffic Calming on Local and Minor Collector Roads

2025 Work Plan

- Design and public consultation will be completed on the following streets and construction will follow.
 - Gable Drive from Sheridan Garden Drive to Wynten Way.
 - Grand Boulevard from Eighth Line to Upper Middle Road.
 - Oxford Avenue from Upper Middle Road to McCraney Street.
 - Queen Mary Drive Bond Street to its northerly Limits.
 - River Side Drive from Queen Mary Drive to Oakwood Crescent.
 - Southview Road from Pinegrove Road to Rebecca Street.
 - Stevenson Road from Lakeshore Road West to Burloak Drive.
 - Tennyson Drive from Bridge Road to Tansley Drive.
 - Towne Boulevard from River Glen Boulevard to McDowell Avenue.
 - Trevor Drive from Bridge Road to Waterford Street.
 - Wynten Way- Entire Street.
- Construction will be completed on the streets that meet required support for traffic calming implementation.
- Continue with analysis of new traffic calming requests.



□ Level 1 Traffic Calming (New Recommendation)

- The street that fail to meet the traffic calming thresholds by up to 2.0 km/h will be eligible for Level 1 Traffic Calming treatment using.
- In-street flexible signs and Radar Speed Display Sign (RSDS).
- Using planters as a traffic calming treatment is not recommended

☐ Traffic Calming Removal Process (New Recommendation)

- Resident Petition.
- Speed Study Analysis.
- Resident Survey.

☐ Traffic Calming using Local Improvements Act

- Council direction to report back on the opportunity to use Local Improvements Act for implementing traffic calming.
- Ontario Regulation 586/06; Local Improvement Charges Priority Lien Status
- Noise attenuation barriers, sewers and watermains, shore protection and construction or improvement of a highway are the projects that can be constructed using Local Improvements Act.
- Local Improvement Charges to fund warranted or unwarranted traffic calming project is not recommended.

Traffic Calming at Schools on Major Collector and Arterial Roads 2024 Progress

Traffic calming design for following eight school zones will be completed in 2024.

- Oodenawi Public School Sixteen Mile Drive between Harebell Gate and Trailside Drive.
- St. Matthew Catholic Elementary School Nottinghill Gate between Pilgrims Way and Runnymead Crescent.
- West Oak Public School Fourth Line between Glen Valley Road and Westview Terrace/ Brillinger Street.
- Palermo Public School Valleyridge Drive between Dundas Street W and Highvalley Road.
- Captain R. Wilson Public School Grand Oak Trail between Westoak Trails Boulevard and Lionstone.
 Drive/Hemmford Drive.
- Pilgrim Wood Public School Pilgrim Way between Pineway Court/Mapleridge Cres. to Blackburn Drive.
- Forest Trail Public School Pine Glen Road between Dashwood Drive/Oakhaven Drive to Newcastle Crescent.
- o Emily Carr Public School Pine Glen Road between Postmaster Drive to Castlebrook Road.

2025 Work Plan

- Construction 8 Streets
- Design 4 Streets (for 2026 construction)



Valleyridge Drive Traffic Calming

- Valleyridge Drive between Dundas
 Street West and Highvalley Road is a major collector with an elementary school (Palermo Public School).
- Traffic calming measures such as chicanes and curb extensions are not suitable due to closely spaced driveways, bus stops and bicycle lanes.



Speed cushions are recommended on Valleyridge as a one-time exception to the direction regarding speed cushions on major collectors and minor arterial roads.

Pedestrian Crossover (PXO) Construction

2024 Progress

- Construction of fifteen (15) PXOs
- Lighting analysis and design will be completed at 40 existing PXOs and installation at five (5) PXOs.

2025 Work Plan

- Design and construction of fifteen (15) PXOs will be completed in 2025.
- Design and construction of twelve (12) PXOs will be completed in 2025 as part of the Crosstown Heritage Trail construction.
- Design and construction of PXO on Allan Street will be completed in 2025 as part of Wallace Park improvements.
- Lighting analysis, design, and construction five (5) existing PXOs.
- Pedestrian Safety Study Update







Road Safety Initiatives and Community Safety Zones

Road Safety Initiatives

- Marine Drive Safety Assessment In progress, recommended safety treatments will be implemented in 2025.
- Intersection Improvements Construction at six (6) all-way stop locations will be completed in 2024.
- Progress Court Intersection Improvements Design in progress.
- Advance Left-turn Implementations Implementation in progress.
- Crossing Guard Assessments three (3) Crossing Guards will be appointed in 2024.
- Leading Pedestrian Interval (LPI) Implementation Implemented at four (4) intersections.
- In-service Road Safety Reviews In progress.
