In 2016, changes to the Municipal Elections Act, 1996, as amended (MEA), meant that corporations and trade unions were no longer permitted to contribute to candidates. Candidates in the 2018 municipal election, and moving forward, could only receive contributions from individuals who are normally residents of Ontario. The maximum campaign contribution to a single candidate was increased from \$750 to \$1,200. The maximum amount an individual could contribute to multiple candidates running on the same Council or school board is \$5,000.

For the 2022 municipal election, Council approved a contribution rebate program that provided a 50% rebate on all eligible contributions, with a minimum rebate of \$50 and a maximum rebate of \$600 (the maximum campaign contribution to a single candidate is \$1,200, in accordance with the MEA).
