

Development Plan

- Engaged Global Philanthropic in March 2024
- Conducted reviews, analysis and interviews
- Report completed in June 2024
- Key recommendations
 - Clarify our priorities identify
 - Build strategic partnerships with key organisations
 - Apply for charitable status
 - Apply for applicable grants and support opportunities



Opportunities and Challenges

- The Oakville community are passionate about sustainability and aligned in the need for urgent action towards energy transformation
- Industry stakeholders believe in our mission, but they don't see a return on investment from a fundraising perspective
- Interim Executive Director moved on to a new opportunity in June 2024
- We are struggling to hire a qualified, experienced Executive Director with the current context of low salary, precarity, and lack of resources
 - We have had a number of strong, interested candidates, but pay has consistently been a barrier



Current Funding and Future Needs

- Town Funding to date
 - 2020 \$100,000
 - 2021 \$100,000
 - 2022 \$50,000
 - 2023 \$50,000
 - 2024 \$50,000 (still to be released)
 - 2025 \$50,000 proposed
- Significant additional funding is required to fulfill mandate and provide financial sustainability
 - With a number of failed searches, sufficient, ongoing funding is required to ensure that we can hire an Executive Director



Funding needs going forward

- To fulfill our mandate, it has become clear that we need more resources and financial stability.
- Ideal estimated resource needs are:
 - Executive Director \$180,000 including salary and benefits
 - Program manager \$120,000 including salary and benefits
 - Events/communications manager \$100,000 including salary and benefits
 - Plus \$50,000 in consulting and other costs
- Total \$450K
- Each year for three consecutive years depending on new funding sources



Funding needs going forward

- Recognising current funding constraints, alternative option....
 - Executive Director \$180,000 including salary and benefits
 - Events/communications manager \$100,000 including salary and benefits
 - Plus \$20,000 in consulting and other costs
- Total \$300K
- For three consecutive years depending on new funding sources



Next Steps

- Work with Town Staff to discuss metrics, deliverables and review agreement between the Town of Oakville and FEO
- Discuss role in development of updated community energy strategy
- Hire an Executive Director
- Continue to explore opportunities to partner with aligned organisations such as the Centre for Community Energy Transformation based in Peel Region in programming and events
