## **COMMENTS/OPTIONS:**

The tables below provide a summary of new positions added recently due to the downloading of responsibilities to the town from Halton Region and Conservation Authorities as well as legislative changes.

The new 2023 and 2024 positions, and the proposed positions in 2026, along with the dollar impact and percentage of the tax levy is provided. The implications of these changes have been felt specifically in Planning & Development and in Transportation & Engineering. In addition to these positions, the 2025 staff-prepared, draft budget includes \$0.60 million (0.23% of tax levy) in revenue loss related to legislative changes. Positions with net zero impact on the tax levy are due to recoveries from fees. The total impact of the positions added in 2023 and 2024 as well as the revenue loss in 2025 is \$1.17 million (0.48% of tax levy).
