Subject: Revised 2023 Housing Target Performance and Building Faster Fund Allocation Notice

To help achieve our shared goal of building the homes Ontarians need, our government has provided 50 of our largest communities with housing targets. As you are aware, performance against annualized targets is being used to determine allocations and eligibility under the Building Faster Fund and is also being reported on the Ministry of Municipal Affairs and Housing's website.

Following a detailed review of Canada Mortgage and Housing Corporation and Ministry of Long-Term Care data in which Oakville participated, I am pleased to confirm that additional conversions in Oakville will be recognized by the ministry towards Oakville's 2023 housing performance. A detailed breakdown is included below:

Since the Ministry will recognize additional conversions towards Oakville's 2023 performance, your municipality has now met 80 per cent of its annual housing target for 2023. I would like to congratulate your municipality on this important achievement towards meeting its 2031 housing target and contributing to our shared housing supply goals.

As a result of meeting 80 per cent of its annual housing target for 2023, I am pleased to inform you that Oakville is now eligible for funding through the Building Faster Fund based on its revised 2023 performance in the amount of \$7,058,182 for the 2024 BFF program year.

To receive this funding for 2023 performance, Oakville must submit an Investment Plan to the ministry for approval and have a signed Transfer Payment Agreement (TPA) in place. <u>This letter will</u> serve as the Allocation Notice for Oakville for the first Program Year under the TPA.

MMAH staff will reach out to officials for the Town of Oakville with detailed next steps and instructions to complete these requirements.
