

# **Considerations During Review**


- Clarifying and simplifying language
- Balancing the interests of candidates, registered third party advertisers, registered referendum committees, voters and staff to ensure an equitable election process
- Ensuring the provisions of the by-law are enforceable
- Ensuring that health and safety is protected
- Providing standards that are unbiased and consistent



# **Public Consultation Process**

- An online questionnaire was available on the town's website for 21 days in March 2024
- > 317 responses were received and reviewed
- ➢ 8 public open houses were held
  - 1 at Town Hall
  - 1 in each of the seven wards
  - Attendees were invited to provide feedback on specific questions related to election sign regulations






- 73% of respondents indicated they consider election signs as visual clutter
- 55% of respondents indicated they consider elections signs as a distraction while driving
- 37% of respondents indicated signs are a necessary part of a democratic election
- 30% of respondents indicated that signs are a good way to promote a candidate

Note: Respondents were able to select multiple responses






- 63% of respondents thought the current display period of 45 days prior to an election is too long
- Majority of respondents indicated display period should be 30 days

#### DISTANCE BETWEEN SAME CANDIDATE SIGNS


■ Keep the same ■ 20m ■ Other ■ 15m ■ No separation distance

# Constraints with Current Regulations

- The cumbersome nature of accessing election sign provisions in the Sign By-law
- > The large number of election signs resulting in sign blight
- The challenges with administering the current sign deposit program
- Enforcement & the storage of signs removed by MES due to non-compliance with the Sign By-law



# **Proposed Regulations**

**Election Sign Display Period:** Reduce municipal election sign display period from 45 to 30 days before voting day; federal and provincial election periods remain unchanged.

**Placement Restrictions:** Prohibit election signs on road allowances or boulevards adjacent to residences without occupant consent, excluding multi-unit buildings.

**Size Limits:** Restrict election signs to a maximum of 1.22m in height and width, with a sign area limit of 1.49m<sup>2</sup>.

**Spacing Requirement:** Increase minimum distance between signs for the same candidate from the current 10m to 20m.

**Non-Compliance Storage:** Reduce storage duration for non-compliant signs from the current 30 days to 7 days.

**Permit Program:** Replace the current deposit system with an election sign permit program for better administration and accountability.



# 2025 Fees & Enforcement

- Permit Fee: A non-refundable election sign permit fee is \$231.
- Violation Penalty: Signs violating the by-law will be removed; removal costs \$58 per retrieval. Candidates will be notified.
- Post-Election Retrieval: Retrieval fee for signs after election day is \$14 per sign.
- Administrative Penalties: Non-compliance may incur a \$300 penalty, with escalated penalties of \$400 for a second offence and \$500 for a third offence.



# **Communicating New Regulations**

- Website Updates: The town's website and social media will provide clear election sign regulation guidance to promote compliance.
- Candidate Guide: A detailed guide will be created to support candidates with updated by-law regulations.
- Online Portal: The election sign permit process will be integrated into the online portal.
