

- The Old Oakville Heritage Conservation District has been in place since 1981/2.
- Old Oakville Heritage Conservation
 District Plan and Guidelines that serves to
 manage change in Old Oakville has not
 been updated since that time.
- The planning process started in 2021 and consists of two major components – the District Study and the District Plan and Guidelines.
- In February 2024, Council approved the District Study and directed staff to begin the new District Plan and Guidelines.
- First draft Plan released in May 2024. Current draft released in February 2025.





Public Information Meeting


The Town of Oakville has released the first draft of the Old Oakville Heritage Conservation District Study as part of the process to update the District, which lies between Robinson Street and Lake Ontario.

The Draft Study includes the history of the area, a description of the cultural heritage value of the area and its significant features.



Timeline

- Final revisions to be made to Draft Plan
- Draft Plan and By-law to Planning & Development Council – March 17, 2025





Staff recommendation:

- That the Heritage Oakville Advisory Committee endorse the adoption of the Old Oakville Heritage Conservation District Plan and Guidelines dated February 2025 as the Heritage Conservation District Plan required by section 41.1 (1) of the Ontario Heritage Act, attached as Appendix A to the report dated February 11, 2025, from the Planning and Development Department; and,
- 2. That the Heritage Oakville Advisory Committee endorse the designation of the Old Oakville Heritage Conservation District under Section 41 of the *Ontario Heritage Act*.
