^ Variable- City of Ottawa:

If the total of the applicant's contribution(s) to all participating candidates is \$25.01 but not more than \$100, the rebate is 50% of the contribution; If the total of the applicant's contribution(s) to all participating candidates is \$100.01 but not more than \$200, the rebate is \$50 plus 25% of the amount by which the contribution(s) exceeds \$100; and the maximum rebate to an individual shall not exceed \$75. Minimum contribution is \$25.01, Maximum rebate is \$75.00

***Maximum allowable rebate:** The maximum rebate to an individual shall not exceed \$75, except for instances where the candidate withdrew their nomination in accordance with the MEA. In such instances, contributors are eligible for a 75 per cent rebate up to a maximum of \$900 for their contributions to that campaign.

*Number of candidates to use program: While 105 candidates (85% of all eligible candidates) registered to participate in the Contribution Rebate Program, only 64 candidates (61%) met the requirements of the program.
