A by-Law to Amend By-Law 1981-066 (The Fire Route By-Law)

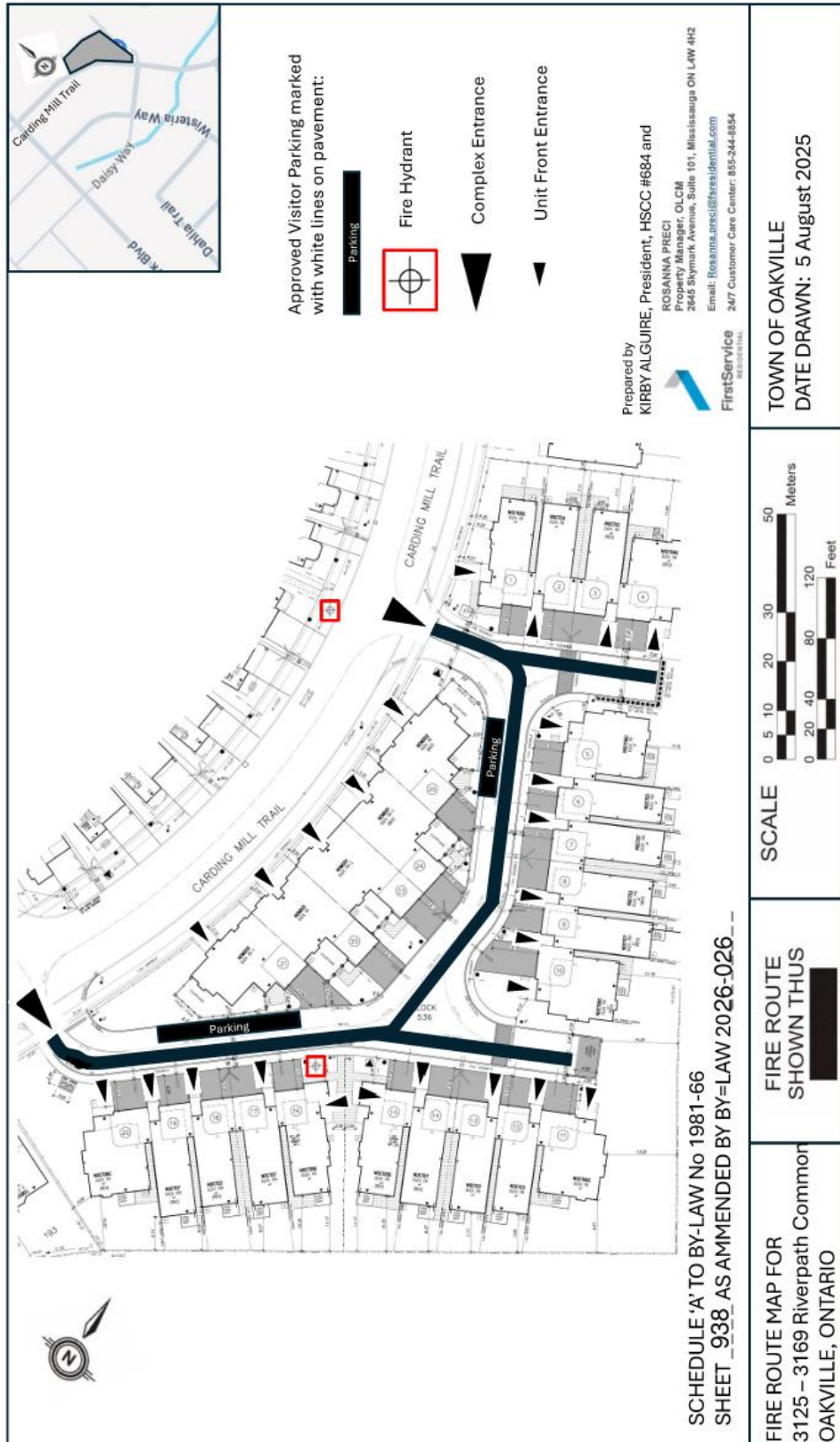


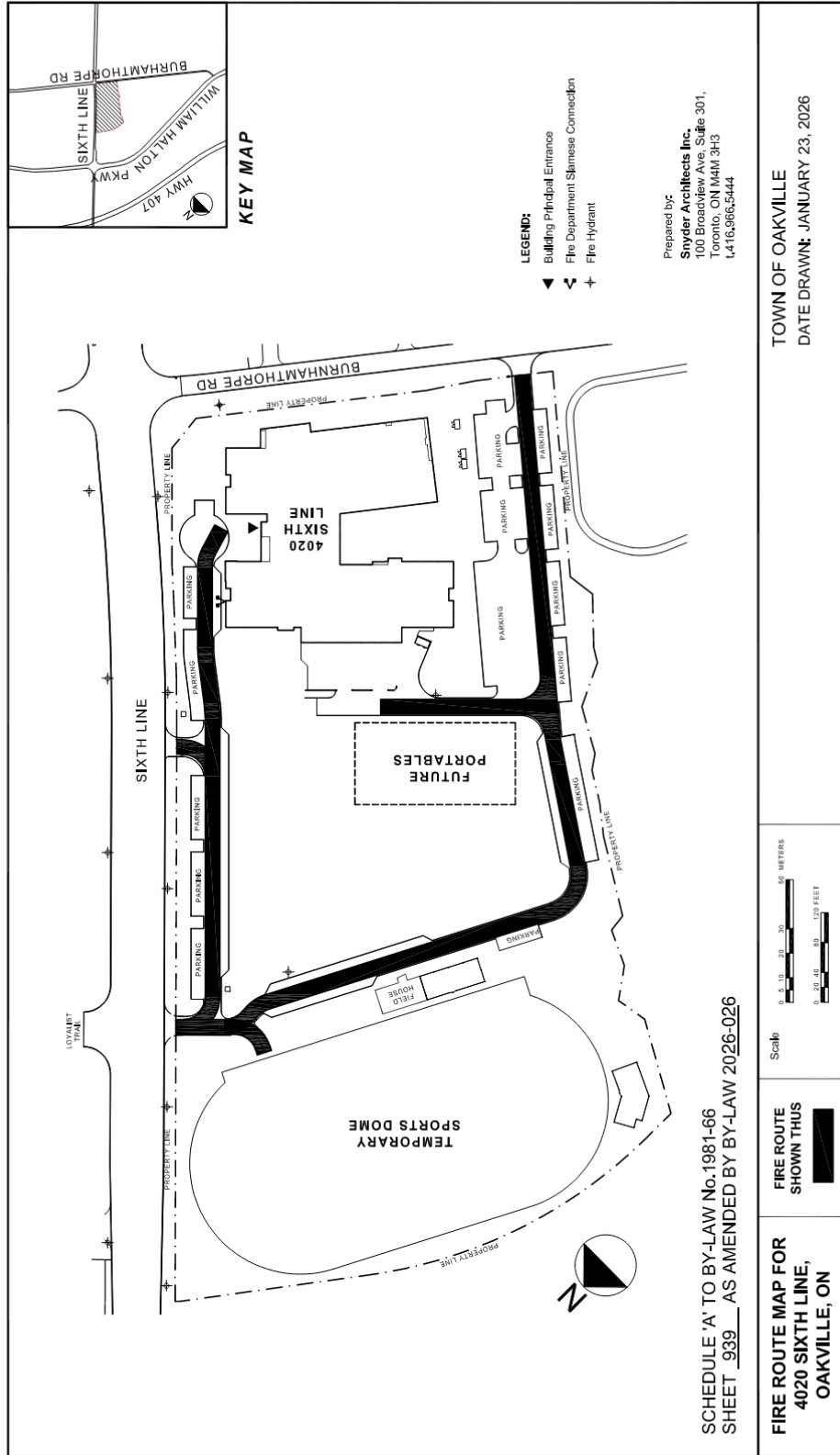
FIRE ROUTE SHOWN THUS [redacted]

 OAKVILLE, ONTARIO

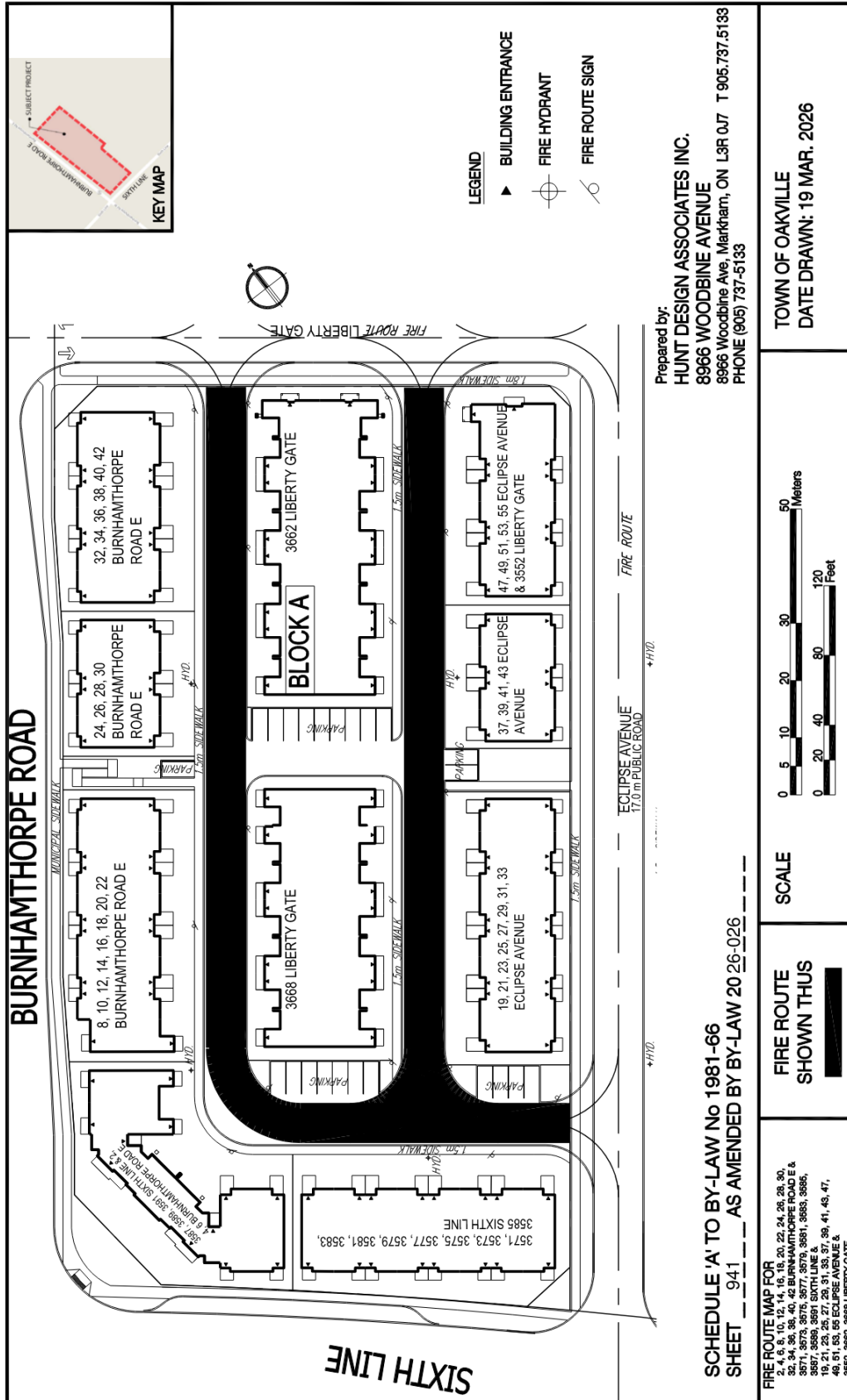
