# 1. Excellent - but has anyone noticed that downtown Oakville is beginning to look a bit like a ghost town? (11 votes)

Suggest the town strongly encourage whomever owns these properties to lower the rents...pronto!

### 2. Please protect our green space (9 votes)

With so many houses built in north of Dundas, Oakville is losing it charming and green space. Do we really have to sacrifice our green space in order to achieve growth?

### 3. Trees Please! (5 votes)

East Dundas is looking like a Concrete Jungle. Can we PLEASE have trees planted on the median islands (Dundas between Trafalgar and 9th Line)?

# 4. Save Glen Abbey Golf Course green space (3 votes)

#### 5. Active transportation facilities (2 votes)

Include more north/south cycling routes in the Oakville Active Transportation plan. Currently, the safest way to get from North Oakville to the downtown, is a singular underpass below the QEW at the foot of Sixth Line.

Progress has been made on the Fourth Line overpass, Third Line, Dorval, and Trafalgar are a cyclists' worse nightmare.

If the Glen Abbey Golf Course gets converted to housing, a provision for a bike path along Six Mile Creek (from Dundas to Lakeshore) can be made to facilitate this idea.

# 6. Buy or retro fit snow plows with a boom that can by dropped down across driveways to prevent a snow dam being formed (2 votes)

I saw this in Europe. Residents will love you for it.

# 7. Designed Road Corner or Roundabout, use some artistic sculptures (2 votes)

# 8. Fiscal Sustainability (1 vote)

Make Lakeshore and Downtown more cycle friendly with a fully designated cycle lane.

### 9. Cats should be allowed to roam (1 vote)

If cats are not allowed to go outside to roam then perhaps dogs should not be allowed outside on any public land in Oakville. ### 10. Leaf Blowers should NOT be banned (1 vote)

As the Town only comes around a couple times a year it falls to the residents to pick up the slack. 10-15 minutes with leaf blower replaces an hour and a half of sweeping with the broom. 10-15 minutes with the machine for over 200 feet of sidewalk and 200 feet of road side with six large and messy trees I think is a very efficient speed with no excessive noise made.

It's nice that the stay at home and retired residents have lots of time to complain about leaf blowers to the Town rather than just going outside to speak to their neighbours. But for those of us who work full time modern conveniences are a necessity. I hope Town Council remembers that when they make their decision.
