RECOMMENDATION:

That a Partial Release of Agreements H426778, H457170, H667427, H772167 and H813338 be executed in accordance with By-law 2013-057.

KEY FACTS:

The following are key points for consideration with respect to this report:

- Stellar Construction Enterprises Limited (“Stellar”), the owner of the property at 2500-2530 Hyde Park Gate, has agreed to transfer certain lands designated as Parts 1 to 4 on Plan 20R-19801 to the Regional Municipality of Halton (the “Region”) for a road widening and future road improvements at the southwest corner of Dundas Street West and Hyde Park Gate.
- The title to the property is subject to two subdivision agreements registered as H426778 and H457170, two site plan agreements registered as H667427 and H772167 and a minor variance agreement registered as H813338.
- The solicitors for Stellar have requested that the Town release these agreements from the road widening lands in order to transfer these lands to the Region with clear title.

BACKGROUND:

COMMENT/OPTIONS:

The Development Engineering Department has no objection to the release of the two subdivision agreements from the road widening lands. The Planning Services Department has no objection to the release of the two site plan agreements and the minor variance agreement from the road widening lands. The Legal Department does not consider there to be any exposure to the Town in partially releasing these
