

## THE CORPORATION OF THE TOWN OF OAKVILLE

## **BY-LAW NUMBER 2016-064**

A by-law to amend By-law 1984-1 (The Traffic By-law)

WHEREAS is it desirable to amend By-law 1984-001 by:

a) Introducing a new paragraph in Part III – Parking and Stopping, Section 5, Subsection 8 (XI), on Page 19, as follows:

# Stopping prohibited

No person shall at any time stop a vehicle in the following places, unless otherwise posted,

- (xi) within an intersection or within 10 metres of an intersection, except within the intersection named or described in Column 1 of <a href="Schedule">Schedule</a> "33" to this by-law of said schedule; and
- b) Introducing "No Parking for Restricted Times max. 20 Minutes at Anytime" provisions along both sides of MARINE DRIVE from BRONTE ROAD to JONES STREET: and
- Introducing "No Parking for Restricted Times max. 20 Minutes at Anytime" provisions along the north side of KERR STREET from LAKESHORE ROAD WEST to SPEERS ROAD; and
- d) Introducing "No Parking at Anytime" restrictions on both sides of SIXTEEN MILE DRIVE from NEYAGAWA BOULEVARD to SIXTH LINE; and
- e) Introducing "No Parking at Anytime" restrictions on both sides of KAITTING TRAIL from PRESERVE DRIVE to SIXTH LINE; and
- f) Introducing "No Parking at Anytime" restrictions on both sides of ELLEN DAVIDSON DRIVE from HINES DRIVE to BETSY DRIVE; and
- g) Introducing "No Parking at Anytime" restrictions on both sides of PRESERVE DRIVE from DUNDAS STREET WEST to ITS NORTHERLY LIMITS; and



- h) Introducing "No Parking at Anytime" restrictions on both sides of JANICE DRIVE from KAITTING TRAIL to SIXTEEN MILE DRIVE; and
- i) Introducing "No Parking at Anytime" restrictions on both sides of ISAAC AVENUE from KAITTING TRAIL to SIXTEEN MILE DRIVE; and
- j) Introducing "No Parking at Anytime" restrictions on both sides of LARRY CRESCENT from SIXTEEN MILE DRIVE to SIXTEEN MILE DRIVE; and
- k) Introducing "No Parking at Anytime" restrictions on both sides of MCWILLIAMS CRESCENT from SAWMILL STREET to SAWMILL STREET; and
- Introducing "No Parking at Anytime" restrictions on both sides of HOEY CRESCENT from SAWMILL STREET to SAWMILL STREET; and
- m) Introducing "No Parking at Anytime" restrictions on both sides of SAWMILL CRESCENT from MCWILLIAMS CRESCENT/HOEY CRESCENT to PRESERVE DRIVE; and
- n) Introducing "No Parking at Anytime" restrictions on both sides of KINGSHOLM DRIVE from NORTH PARK BOULEVARD to SAWMILL STREET; and
- Introducing "No Parking at Anytime" restrictions on both sides of MASTERMAN CRESCENT from COLTON WAY to COLTON WAY; and
- p) Introducing "No Parking at Anytime" restrictions on both sides of CULP TRAIL from COLTON WAY to CHERRYHURST ROAD; and
- q) Introducing "No Parking at Anytime" restrictions on both sides of CHERRYHURST ROAD from HINES DRIVE to COLTON WAY; and
- r) Introducing "No Parking at Anytime" restrictions on both sides of MAGNOLIA CRESCENT from HINES DRIVE to HINES DRIVE; and
- s) Introducing "No Parking at Anytime" restrictions on both sides of JESSIE CAVERHILL PASSAGE from HINES DRIVE to CHERRYHURST ROAD; and
- t) Introducing "No Parking at Anytime" restrictions on both sides of COLTON WAY from SIXTEEN MILE DRIVE to CHERRYHURST ROAD/MASTERMAN CRESCENT; and



- u) Introducing "No Parking at Anytime" restrictions on both sides of HINES DRIVE from SIXTEEN MILE DRIVE to NORTH PARK BOULEVARD; and
- v) Introducing "No Parking at Anytime" restrictions on both sides of SARAH CLINE DRIVE from ELLEN DAVIDSON DRIVE to LANE 143/LANE 144; and
- w) Introducing "No Parking at Anytime" restrictions on both sides of JEMIMA DRIVE from ELLEN DAVIDSON DRIVE to LANE 141; and
- x) Introducing "No Parking at Anytime" restrictions on both sides of BETSY DRIVE from CASHMERE GARDENS to ELLEN DAVIDSON DRIVE; and
- y) Introducing "No Stopping at Anytime" restrictions on both sides of SIXTEEN MILE DRIVE from NEYAGAWA BOULEVARD to SIXTH LINE; and
- z) Introducing "No Stopping at Anytime" restrictions on both sides of KAITTING TRAIL from PRESERVE DRIVE to SIXTH LINE; and
- aa)Introducing "No Stopping at Anytime" restrictions on both sides of ELLEN DAVIDSON DRIVE from HINES DRIVE to BETSY DRIVE; and
- bb)Introducing "No Stopping at Anytime" restrictions on both sides of PRESERVE DRIVE from DUNDAS STREET WEST to ITS NORTHERLY LIMITS; and
- cc) Introducing "No Stopping at Anytime" restrictions on both sides of JANICE DRIVE from KAITTING TRAIL to SIXTEEN MILE DRIVE; and
- dd)Introducing "No Stopping at Anytime" restrictions on both sides of ISAAC AVENUE from KAITTING TRAIL to SIXTEEN MILE DRIVE; and
- ee)Introducing "No Stopping at Anytime" restrictions on both sides of LARRY CRESCENT from SIXTEEN MILE DRIVE to SIXTEEN MILE DRIVE; and
- ff) Introducing "No Stopping at Anytime" restrictions on both sides of MCWILLIAMS CRESCENT from SAWMILL STREET to SAWMILL STREET; and
- gg)Introducing "No Stopping at Anytime" restrictions on both sides of HOEY CRESCENT from SAWMILL STREET to SAWMILL STREET; and



- hh)Introducing "No Stopping at Anytime" restrictions on both sides of SAWMILL CRESCENT from MCWILLIAMS CRESCENT/HOEY CRESCENT to PRESERVE DRIVE; and
- ii) Introducing "No Stopping at Anytime" restrictions on both sides of KINGSHOLM DRIVE from NORTH PARK BOULEVARD to SAWMILL STREET; and
- jj) Introducing "No Stopping at Anytime" restrictions on both sides of MASTERMAN CRESCENT from COLTON WAY to COLTON WAY; and
- kk) Introducing "No Stopping at Anytime" restrictions on both sides of CULP TRAIL from COLTON WAY to CHERRYHURST ROAD; and
- II) Introducing "No Stopping at Anytime" restrictions on both sides of CHERRYHURST ROAD from HINES DRIVE to COLTON WAY; and
- mm) Introducing "No Stopping at Anytime" restrictions on both sides of MAGNOLIA CRESCENT from HINES DRIVE to HINES DRIVE; and
- nn)Introducing "No Stopping at Anytime" restrictions on both sides of JESSIE CAVERHILL PASSAGE from HINES DRIVE to CHERRYHURST ROAD; and
- oo)Introducing "No Stopping at Anytime" restrictions on both sides of COLTON WAY from SIXTEEN MILE DRIVE to CHERRYHURST ROAD/MASTERMAN CRESCENT; and
- pp) Introducing "No Stopping at Anytime" restrictions on both sides of HINES DRIVE from SIXTEEN MILE DRIVE to NORTH PARK BOULEVARD; and
- qq)Introducing "No Stopping at Anytime" restrictions on both sides of SARAH CLINE DRIVE from ELLEN DAVIDSON DRIVE to LANE 143/LANE 144; and
- rr) Introducing "No Stopping at Anytime" restrictions on both sides of JEMIMA DRIVE from ELLEN DAVIDSON DRIVE to LANE 141; and
- ss) Introducing "No Stopping at Anytime" restrictions on both sides of BETSY DRIVE from CASHMERE GARDENS to ELLEN DAVIDSON DRIVE; and




**WHEREAS** it is necessary to amend the Traffic By-law to enact these provisions with the appropriate schedules attached.





## (8) Stopping Prohibited

## (a) Stopping Prohibited

No person shall at any time stop a vehicle in the following places, unless otherwise posted,

- on or within 6 meters of a crosswalk other than at an intersection controlled by a traffic signal,
- on or within 25 meters of any crosswalk at an intersection controlled by a traffic signal,
- (iii) within 3 metres of a fire hydrant,
- (iv) in such a position so as to obstruct any pedestrian passageway.
- (v) adjacent to any median strip or island,
- (vi) on either side of a highway that is divided by a median strip,
- (vii) within 15 metres of either side of a signed bus stop, except public transit buses,
- (viii) on or within 100 metres of a bridge, over, under or across which the highway passes,
- (ix) within a school bus loading zone, excepting school buses,
- (x) on or within 3 metres of a railway crossing,
- xi) within an intersection or within 10 metres of an intersection, except within the intersection named or described in Column 1 of Schedule "33" to this by-law of said schedule.

#### (9) No Stopping where Authorized Signs are on Display

#### (a) Prohibited Stopping

Where authorized signs to that effect are on display, no person shall at any time stop a vehicle in the following places,

- (i) within 50 metres or less, of an intersection on a highway
- (ii) on the side of a roadway abutting any school property,
- (iii) on the side of a roadway abutting any park or playground,
- (iv) in front of or within 15 metres of either side of any Fire Hall, on the same side of the highway as the Fire Hall, or within 45 metres from a point in the curb or edge of roadway directly opposite the centre point of the Fire hall on the opposite side of the highway from the Fire Hall,
- (v) on any highway or parts thereof named or described in Column 1 of <u>Schedule "6"</u> to this By-law from the location identified in Column 2 to the location identified in Column 3 on the side or sides of the highway set out in Column 4 of said Schedule.
