 It is an open session and Council may hear oral submissions from members of the public.

BACKGROUND:

As part of the town's ongoing Official Plan Review, the North Oakville West Secondary Plan and the Palermo Village Growth Area are being reviewed. Substantial work has already taken place as part of these reviews, and has resulted in a proposed town-initiated official plan amendment (OPA).

The proposed OPA for the North West Area and Palermo Village, excluding the Hospital District, was presented at a statutory public meeting of Planning and Development Council on November 23, 2020 (Agenda Item 3). The accompanying staff report provided a detailed overview of the study process undertaken, applicable policy frameworks, and other matters that were considered when developing the proposed OPA. Council heard public delegations and identified additional planning matters to be considered as part of a final recommendation to Council.

At the same meeting, Council requested that a workshop be set up in regard to Agenda Item 2, being the proposed town-initiated OPA for the Hospital District (File No. 42.15.57). Given the comprehensive nature of the planning work being undertaken in the northwest part of the town, it was decided that a workshop should also be held for the North West Area and Palermo Village.

COMMENT/OPTIONS:

At the Council Workshop, staff will facilitate a discussion on the town-initiated OPA.

CONCLUSION/NEXT STEPS:

Following the Council Workshop, staff anticipate bringing forward a recommended OPA for Council's consideration for adoption in March 2021. It would then be submitted to the Region of Halton for approval. It is critical that this timeframe is met to ensure coordination with the Region of Halton's Municipal Comprehensive Review (Official Plan Review).
