

## THE CORPORATION OF THE TOWN OF OAKVILLE

## BY-LAW NUMBER 2018-159

A by-law to declare that certain land is not subject to part lot control (Blocks 253, 254, 255, 266, 267, 268, 269, 270, 271, 284, 285, 286, 287, 288, 289, 290 and 291, Plan 20M-1198 – Pendent Developments Limited)

**WHEREAS** By-law 2006-125 delegates to the Director of Planning Services the authority to approve certain applications to designate lands not subject to part lot control; and

**WHEREAS** the Director of Planning Services has approved such an application for the lands described in Schedule "A";

## COUNCIL ENACTS AS FOLLOWS:

- Part lot control pursuant to subsection 5 of Section 50 of the Planning Act, R.S.O. 1990, c.P-13, as amended does not apply to lands as set out in Schedule "A" attached hereto.
- 2. This by-law expires one (1) year from the date it has been passed by Council.
- 3. Schedule "A" forms part of this by-law.
- 4. The solicitor is hereby authorized to amend the parcel designation, if necessary, upon registration of this by-law.
