#### RECOMMENDATION:

That a Transfer Release and Abandonment of Easement HR1290642 be executed in accordance with By-law 2013-057.

### **KEY FACTS:**

The following are key points for consideration with respect to this report:

- In connection with Davis-Minardi Home Corp. Plan 20M-1164, the Town acquired a temporary turning circle easement at the east end of Charles Biggar Drive from the abutting landowner, Pendent Developments Limited. The Transfer of Easement was registered on August 14, 2015 as HR1290642.
- The abutting lands have now been registered as Plan 20M-1192 (Mattamy Preserve Phase 3A) with Charles Biggar Drive continuing through this plan, and the turning circle easement is no longer required.

#### BACKGROUND:

In connection with Davis-Minardi Home Corp. Plan 20M-1164, the Town acquired a temporary turning circle easement at the east end of Charles Biggar Drive from the abutting landowner, Pendent Developments Limited. The Transfer of Easement was registered on August 14, 2015 as HR1290642. The abutting lands have now been registered as Plan 20M-1192 (Mattamy Preserve Phase 3A) with Charles Biggar Drive continuing through this plan, and the turning circle easement is no longer required.
