RECOMMENDATION:

That Item 12, "Discussion Paper - Integrated Growth Management Strategy (IGMS), Regional Official Plan Review" be deferred.

KEY FACTS:

The following are key points for consideration with respect to this report:

- As part of the ongoing Regional Official Plan Review, the Integrated Growth Management Strategy (IGMS) project will determine how to accommodate forecasted population and employment growth in the region to 2041. An initial IGMS technical report outlining a series of growth scenarios was to be presented to Regional Council later this month.
- On May 2, 2019 the Province released a Housing Supply Action Plan and A Place to Grow: Growth Plan for the Greater Golden Horseshoe ("A Place to Grow"), which will come into effect on May 16, 2019. Bill 108 was also released on May 2, 2019. It proposes to amend thirteen Provincial statutes with respect to housing, other development and various other matters.
- Town and Regional staff need some time to better understand the implications of these changes. As such, Halton Region will be deferring its IGMS technical report. It is requested that the town's related IGMS discussion paper also be deferred so that any potential revisions to the growth scenarios may be addressed.

BACKGROUND:

The 2017 Growth Plan for the Greater Golden Horseshoe ("2017 Growth Plan") required Halton Region to be planned to accommodate 1,000,000 people and 470,000 jobs by 2041. The Halton Integrated Growth Management Strategy (IGMS) is a process coordinated by Halton Region to figure out where in the region these people and jobs should go.

In light of the Provincial policy changes and proposed legislative changes announced on May 2, 2019, the Region's original IGMS project timeline will be revised.

It is noted that A Place to Grow maintains the same 2041 population and employment forecasts for Halton Region.

Regional Council Workshop

A Regional Council workshop was held on April 10, 2019 (before the Provincial changes) to introduce the IGMS and eight preliminary growth scenarios with varying amounts of new greenfield designation and intensification.

All of the scenarios would accommodate 157,400 new housing units from 2016 to 2041 to reach the forecasted population of 1,000,000 people, in conformity with the 2017 Growth Plan.

Regional Council provided feedback and requested additional information to be included in future reports. - the built boundary; and,
- designated greenfield areas.
