The purpose of this letter is to advise that the Halton District School Board is inviting offers to purchase the above noted lands in accordance with Ontario Regulation 444/98. The background to this matter is described below.

Background

Since the purchase of Oakville SW #1 ps (Lakeshore Woods) site in 2013, the site has remained vacant and the Ministry has not granted funding for construction. By motion of the Halton District School Board, the Board resolved that selected real property comprising 5.561 acres, located in the Lakeshore Woods Community (ERA 111), on Nautical Boulevard between Alison Crescent and Innville Crescent (Oakville, Ontario) was not required for the purposes of the Board. The Board seeks to dispose of such lands in accordance with Ontario Regulation 444/98 and hereby invites your agency or public entity to submit an expression of interest and eventually an offer to purchase.

Expressions of Interest and Offer to Purchase

Your agency or public entity must submit to the board an expression of interest in response to the proposal before the expiration of 90 days after the day on which the board issued the proposal. Acceptance of offers to purchase will not be made for a period of ninety (90) days following issuance of this proposal; only offers of purchase that comply with the Regulation will be considered. Agencies or public entities that have expressed an interest in the property have an additional 90 days to submit an offer to purchase at **fair market value.** In the event the Board receives more than one valid offer, the offer of the body with the highest priority determined in accordance with the Regulation will be considered first.

Submission of offers to purchase should be delivered to Ms. Roxana Negoi, Superintendent of Business, Halton District School Board, 2050 Guelph Line, Burlington, Ontario, L7P 5A8.
