#### Where we started

Council endorsed the town's first Environmental Strategic Plan (ESP) in December 2005 and an update was completed in 2011. As the result of a recommendation in the ESP, an Environmental Indicators Program and the first State of the Environment Report (SOER) were developed in 2008. Measuring aspects of the environment can help residents, staff and Council better understand our impact and how we can take action.



As part of our ongoing commitment to environmental sustainability, the SOER is updated every year and focuses on the six goals related to the town's ESP:

- Goal 1 To sustain and enhance our natural environment
- Goal 2 To reduce our resource consumption and waste production
- Goal 3 To establish and support an environmentally friendly transportation network
- Goal 4 To create and support a healthy resilient community
- Goal 5 To foster environmental stewardship through education and community involvement
- Goal 6 To lead in applying best environmental management practices

As the saying goes “what gets measured gets managed”. The SOER assists staff and Council to determine priorities for the environment and gives us information on the programs we’re implementing. It provides quantitative data to residents and our community on how the town’s environment is faring, what actions the town is taking and what we can do. For schools and educators, the SOER can act as a springboard for school projects, teaching concepts or developing school based projects. In general the better our data, the better our choices.

Greenspace and biodiversity	↔	Publicly owned greenspace; Trees planted by town staff; Total suspended solids (aquatic)	The town is in a good position with 2,414 ha of public greenspace as of 2011, however, population increases are causing a decrease in per capita values. Likewise, the town enjoys a tree canopy cover of 29% and while tree planting continues by both staff and volunteers, Emerald Ash Borer and other invasives are creating gaps in the urban forest. Air quality	➡	Average annual ground level ozone; PM <sub>2.5</sub> ; 24 hour exceedances	Ozone showing very moderate increases since 2004 and PM2.5 climbing since 2009.
Water quality	➡	Mean chloride and phosphorus in creeks	Chloride generally decreasing in all creeks and all are within PWQO standards. Phosphorus increasing in in Fourteen and Sixteen Mile Creeks since 2009 and all
Climate change	➡	Local annual precipitation and seasonal temperatures	Generally decreasing precipitation and increasing seasonal temperatures following climate change model predictions for province.

Green space access	⬇	Garden plot rentals; Adopt-a programs; kms of trails; outdoor recreational facility space	Adopt-a program participation rates are showing moderate increases, garden plot rentals remain steady and per capita outdoor recreation facility space has been
Green development	⬇	Housing completions; Building permits	Housing completions are moving towards more dense levels with townhouse development outpacing single family home construction at 66.4% vs 33.6%. Building permits issued continues to climb since 2009, and in 2011 gains were

Environmental outreach events	↔	Number of outreach events by town staff	Environmental outreach and education events by town staff declined slightly but increases were seen in the number of larger events and number of participants.
EcoSchools	➡	EcoSchools certification	EcoSchools continues to be a positive program within the school boards, however, declines were seen in 2011 primarily in the bronze category.

ESP implementation	⬇	Implementation progress	Implementation of the updated ESP is ongoing.
