# **RECOMMENDATION:**

That the annual statement of remuneration and expenses paid to members of Council and appointed members of the Committee of Adjustment prepared by the Financial Operations department, in accordance with Section 284 of the *Municipal Act, 2001,* be received.

#### **KEY FACTS:**

The following are key points for consideration with respect to this report:

- All expenses report are in accordance with approved corporate policies and have been provided for in the 2015 approved budget.
- The budget provision for the "Community Outreach & Professional Development" related expenses was \$3,700 per Council member.
- Overall, the budget provision for the Community Outreach & Professional Development was under spent.
- The Municipal Election Compliance Audit Committee did not meet in 2015.
- An annual professional development budget of \$15,000 was included in the 2015 budget for councillors to attend Federation of Canadian Municipalities (FCM) and Association of Municipalities of Ontario (AMO) conferences.

# BACKGROUND:

The *Municipal Act* requires that the Treasurer prepare an annual itemized statement of remuneration and expenses paid in the previous year to each Member of Council in respect of his or her services as a Member of Council or any other body, including a local board, to which the member has been appointed (Appendix A). The Act also requires us to provide itemized statements of remuneration and expenses paid to any individual, other than a member of council, appointed by the municipality to serve as a member of any body, including a local board in respect of his services as a member of that body. This requirement applies to two committees, Committee of

Adjustment and Municipal Election Compliance Audit Committee, but since the Municipal Election Compliance Audit Committee did not meet in 2015, we have prepared an itemized statement for the Committee of Adjustment members only (Appendix B).

#### COMMENT/OPTIONS:

Appendices A and B, as attached, provide itemized statements of remuneration and expenses paid to each Member of Council and the members of the Committee of Adjustment in 2015. All payments were made in accordance with Corporate Policy and provided for in the 2015 approved budget.
