#### 5. Business Arising from the Minutes

## a. <u>Item 6.b. – Request to Amend Heritage Designation By-law</u> 1990-109 - 1399 Lakeshore Road East

Susan Schappert, Heritage Planner, responded to a question advising that the staff recommendation to amend the heritage designation by-law (i.e., to remove the house as a heritage attribute of the property, update the property address, and provide more clarity on its heritage attributes) was approved by Planning and Development Council on November 28, 2016. Ms. Schappert advised that staff are working with the applicant on the wording of the designation by-law in order to strengthen the by-law with respect to the stables, noting that they are a very important heritage attribute of the property.

Susan Schappert responded to a question regarding the amendment to the heritage designation by-law, advising that she would circulate the draft by-law by email to the committee for any further comments.

The committee commented on the need to be aware of the impact of allowing significant additions or alterations to original heritage buildings in the future, and to have regard to maintaining the heritage attributes.
