BY-LAW NUMBER 2017-003

A by-law to dedicate certain land as part of a public highway (Parts 1, 2, 3, 4, 5, Plan 20R-20462, Blocks 51, 52, 53, Plan 20M-1163, Block 133, Plan 20M-1173 - Ernest Applebe Boulevard, Fowley Drive, Mintwood Circle, Squire Crescent, Lane 156)

COUNCIL ENACTS AS FOLLOWS:

- That certain parcels of land more particularly described in Paragraph 1 and Paragraph 9 in Schedule "A" attached hereto are hereby declared to be part of a public highway, namely, Lane 156.
- 2. That certain parcels of land more particularly described in Paragraph 2 and Paragraph 8 in Schedule "A" attached hereto is hereby declared to be part of a public highway, namely, Fowley Drive.
- 3. That certain parcels of land more particularly described in Paragraph 3 and Paragraph 5 in Schedule "A" attached hereto is hereby declared to be part of a public highway, namely, Mintwood Circle.
- 4. That certain parcels of land more particularly described in Paragraph 4 and Paragraph 6 in Schedule "A" attached hereto is hereby declared to be part of a public highway, namely, Ernest Applebe Boulevard.
- 5. That certain parcel of land more particularly described in Paragraph 7 in Schedule "A" attached hereto is hereby declared to be part of a public highway, namely, Squire Crescent.
- 6. Schedule "A" forms part of this by-law.
